

Gender Audit: An Introduction

A. Introduction Of the Institution

Shree Eknatharao Sahadu Shete Arts Commerce & Science College began its journey way back in the year 2019, when it was founded by the Shikshan Mandal Bhagur. Which felt the dire need for educational renaissance especially among the underprivileged and tribal area? Thereafter over the 6 years, it has gradually risen itself and gained exceptional momentum enough to be recognized as an established seat of learning.

The college is affiliated to Savitribai Phule Pune University. The college offers full-fledged three years Government-aided degree courses namely B.A. (English, Marathi, Hindi, Geography, Political Science, History, Economics), B.Com. (Business Administration, Marketing and Salesmanship, Financial Account, Business mathematics and statistics, Business Economics, Costing and Work Accounting, Marathi, Hindi, English), BSc (physics, chemistry, Mathematics, zoology, botany, Geography, Physical Education).

The College pride itself by possessing a rare distinction of having a highly qualified, dedicated and enthusiastic staff with NET/SET Qualification. In addition to conventional teaching, more stress is laid on imbibing moral and ethical character, career planning and guidance, sports and co-curricular activities.

B. What is a Gender audit?

Gender Audit is an attempt to study whether the colleges has a good gender balance. It tries to see whether college follows government rules, policies and actions formulated for up-gradation of women society. The Gender Audit tries to access the impact of its current and proposed policies on gender equality. Although there is no standard approach for carrying out a gender audit, international organizations use two main approaches: participatory in gender audit and the gender integration framework. A gender audit usually includes two dimensions as follows:

➤ **An internal audit:**

This dimension refers to how much an organization fosters gender equality internally within its organizational, managerial structure and internal work and whether these contribute to gender equality in the organization. An internal gender audit monitors and assesses the relative progress made in gender mainstreaming, contributes to capacity building and collective organizational ownership for gender equality initiatives, and sharpens organizational learning on gender.

➤ **An external audit:**

This dimension aims to assess to what extent, an organization mainstreams gender in its policies, programmes, projects and services in terms of content, delivery and evaluation. External gender audits evaluate to what extent gender integration fosters the inclusion of, and benefits to women and men involved in or affected by the organization's policies, programs, projects or services provided. When applied to policies, programmes, projects or services, a gender audit starts by exploring to what extent gender equality is mainstreamed in high-level policy objectives and priorities, and further assesses to what extent policy intentions are actually carried out in specific initiatives (e.g. programmes, projects, services). At the planning level, a gender audit analyses whether there are gender specific objectives or if gender is mainstreamed in the general objectives of the policy in order to guarantee that they contribute to close gender gaps, ensure that women and men benefit equally or in accordance with their gender needs and that inequalities are not perpetuated. Similarly, a gender audit goes on to analyze how gender is mainstreamed into the implementation phase of the policy, programme or project. Finally, a gender audit of the monitoring and evaluation phase investigates whether targets and indicators include a gender perspective both in terms of sex-disaggregated data and progress towards gender equality.

External committee members, Chairman and Internal committee members intended to scrutinize the gender balance within the institution and its practices and focused on the following objectives.

C. Objectives of the gender audit exercise:

- The institute shall take effective measures for the safety and security of all genders.
- There must be an accessible, active, unbiased and confidential Grievance Redressal Cell.
- There shall not be any kind of discrimination on the basis of gender.
- To develop and enhance the self-confidence and self-esteem of girl students, women faculty and staff in the college.
- Overall personality development programs shall be organized, which will develop confidence in the students of the institution.
- To protect girl students from eve teasing and for the same posters to be exhibited at focal places in and around the college.
- A certified consultant to be invited to take care of personal development and confidence building among students.
- Organizing programs to build confidence and instil leadership qualities in the girl students.

- To join hands with IQAC, Anti-ragging committee, and internal complaint committee for creation of gender sensitization.

- To create social awareness about the problems of women and gender discrimination in particular.

- The Audit would enable the organization to identify the impact of gender relations on their agency's culture, processes, programs and organizational performance and vice versa.

The following are the main objectives of the Gender Audit:

- a) To know about the gender balance in the college.
- b) To know about gender perception in the campus.
- c) To reflect and sketch out a road map for gender action.

D. Gender Wise Distribution of Staff:

Gender sensitivity refers to an attempt to encounter and accept people without presumptions. Gender sensitive approach aims at opening, reconstructing and broadening expectations and behavioural models related to gender. Gender sensitive structures respond equally to men and women's specific interests without any presumption based on out dated views. When gender became a major parameter for institutional governance, the institutional leaders stepped forward taking steps to ensure gender equality.

An audit of gender sensitive features in the Institution yielded the following notable points:

- Basic sanitation facility in the form of separate toilets for the students and staff is provided in the common area. Separate toilets for male and female faculty are available.
- There is a Ladies common room provided on the ground of the building.
- There is CCTV monitoring devices installed at different locations and in entry doors in the college.

E. Gender Balance within the Institution:

Gender balance means the existence of a fair ratio of male and female representation within the institution in terms of number of students in the various programmes as well as within the staff structure. The rationale is that traditionally women have lesser access to resources and opportunities due to the social structures which act as inhibitors to access. This result in lesser capability among women which in turn produces a snowball effect on their empowerment and access to development initiatives.

Gender audit team reviewed analysed the operating environment of Shree Eknatharao Sahadu Shete Arts Commerce & Science College Deolali Camp From the analysis, the team understood that the college is operating in an environment where everyone has access to a full range of opportunities to achieve the social, psychological and physical benefits that come from participating and leading in sports and physical activity. Gender equity requires that girls and women be provided with a full range of activity and program choices that meet their needs, interests and experiences. The college always concentrates on students' academic performance along with their overall personality development. Observing gender equality, the girls are provided with various facilities. The lectures of eminent personalities are held on various topics to develop their personality. Our girls' students have

achieved success in the field of cultural activities and sports. The analysis of the responses of students with regard to programme planning and design in college and its activities revealed that most student members feel that the gender equity in policies, programmes of the college is adequate.

In the year 2021- 22 out of 482 total students 43.99 % were female students compared 56.01 % male students. In the year 2022 -23 out of 480 total students 44.58 % were female students compared 55.42 % male students. In the year 2023-24, out of 403 total student's 56.21 % were female students as compared to 43.79% male students. The further year shows continuous increase in female students like 56.61 % in the year 2024-25.

F. Gender Sensitization Initiatives:

By forming various committees like Anti-ragging, Internal Complaints and Sexual Harassment Prevention; at the same time providing adequate facilities to girls, gender equity is kept upright in the college.

The following initiatives have been undertaken by the college for the convenience of girl students:

Shree Eknatharao Sahadu Shete Arts Commerce & Science College Deolali Camp is always avoiding rush and other mishaps, separate provisions have been made at various places for girls.

1. **Ladies Common room:** There is adequate space in the Ladies Common Room and silence is maintained for girls to study.
2. **Girls Washroom:** Girl's washroom is situated on the ground floor of the college.
3. **Drinking Water:** Water Cooler and water purifier have been provided for boys and girls in the college.

The college has established a number of committees to aid girl students and ladies' staff. These committees include:

1. **Anti-Ragging Committee:** As the college forms a constituent part of the Savitribai Phule Pune University, Pune, some of its responsibilities are shared and covered by joint arrangements. The college publishes its regulations in the prospectus. Ragging is a criminal offence and UGC has notified regulations on curbing the menace of ragging in educational institutions. In order to prohibit, prevent and eliminate the scourge of ragging the college has formed an Anti-Ragging Committee. The students Unistress owing to ragging related incidents can approach the Committee.

2. **Women Grievance Redressal Cell/ Vishakha Committee:** As the College formed to resolve the women's grievances regarding gender discrimination and sexual harassment complaints of its students. For gender equality and gender justice in all its intervention and practices Women Grievance Redressal Cell established under THE NATIONAL COMMISSION FOR WOMEN ACT, 1990 (Act No. 20 of 1990) renamed as Vishakha Committee from 2023. The cell is responsible for looking into any complaints filed by students and staff about women Grievance at the college.
3. **NSS for Girls:** Our College has NSS to sensitize students towards societal issues and community services, activities of which are mainly carried out by the students. The NSS unit for girls provides a suitable environment for taking up a career in the social services. The girls are trained and motivated for all kinds of social work in the field. They are motivated to serve the society.
4. **Administrative Committee and Girl student Representative:** Becoming a student representative enables the student to develop and strengthen leadership skills, connect with various internal and external issues and problems, assist fellow students, share experiences and participate in college events for the administrative development.
5. **Internal Complaint Committee :**In pursuance of UGC (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015 read with Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and in partial modification of Office Order No. 449 dated 05.08.2016, Internal Complaints Committee (ICC) is constituted to deal with the complaints regarding to Sexual harassment at work placeThe college has constituted an internal complaint committee (ICC) as per the sexual harassment of women at workplace (prevention, prohibition and redressal) act and rule 2013. Having raised the bar of responsibility and accountability in the Vishakha Guidelines, the Supreme Court placed an obligation on workplaces, institutions and those in positions of responsibility, to uphold working women's fundamental right to equality and dignity at the workplace. It is important to note that the Act provides civil remedy to women in addition to other laws that are currently in force. Consequently, any women who wishes to report instance of sexual

harassment at the workplace has the right to take recourse of both civil and criminal proceedings.

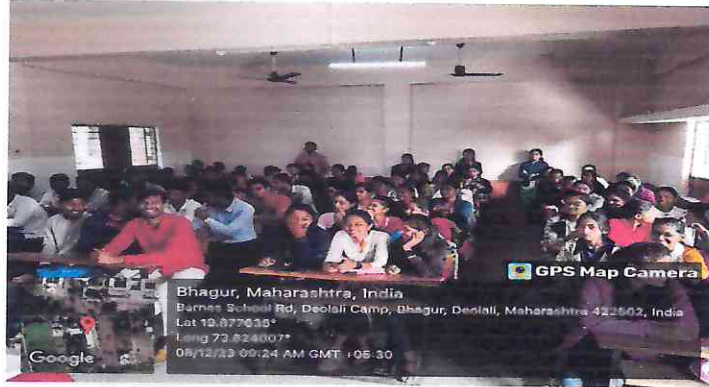

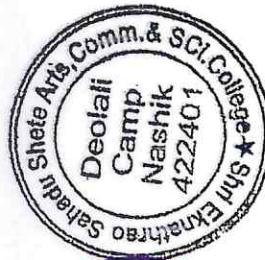
